

Purpose

Use this form if both of the following statements apply to you:

- You are on academic probation or are returning to school after a period of academic probation.
- You have submitted a **2020-21 OSAP Application for Full-Time Students**.

Your eligibility for OSAP funding will be on hold until your completed form is received and reviewed by your financial aid office or the ministry.

Required documents

A copy of your transcripts for your academic probation period may be required. You do not have to purchase official transcripts.

See 'Section B: Required documents' to determine if you need to provide a copy of your transcripts.

Review of academic probation

You may be eligible to have your academic probation removed. Contact your financial aid office if any of the following impacted your ability to maintain satisfactory academic progress:

- a new or pre-existing medical condition;
- a disability-related issue; or
- a family crisis.

How to submit this form

The quickest way to submit your form is to upload it to your OSAP account. Log into the OSAP website and go to your application to use the "Print or upload documents" button. Or, you can submit a paper copy as follows:

If you're going to a school in Ontario:

Deadline

This form and all required documents must be received by your financial aid office or the ministry no later than 40 days before the end of your 2020-21 study period.
